During the quarter ended 30.9.2013, 87 Equity Shares standing in the name of (Late) Shreemati Ambalal Kilachand (one of the Person acting in concert with the Promoters of the Company) were transmitted through IDBI Trusteeship Services Ltd., the Administrator of her Estate, in favour of her legal successors / inheritors by virtue of the Court Order. From the said shares, as per Regulation 10(g) – General Exemption of SEBI (Acquisition of Shares & Takeovers) Regulations, 2011, Shri Harsh Rajnikant Kilachand (one of the Person acting in concert with the Promoters of the Company) has acquired 12 Equity Shares and Shri Amrishi Rajnikant Kilachand (one of the Person Acting in Concert with the Promoters of the Company) has acquired and simultaneously sold 11 Equity Shares. The balance 64 Equity Shares were transmitted to other Non Promoter inheritors. On account of the above, the Shareholding of Promoter and Person acting in Concert with the Promoter has reduced by 75 Equity Shares i.e. from 5596901 Equity Shares (64.928%) to 5596826 Equity Shares (64.927 %).
