Sub: Summary of Proceedings of the 86th Annual General Meeting (AGM) of the Company

Pursuant to Regulation 30 read with Part A of Schedule III of the SEBI (Listing Obligations & Disclosure Requirements) Regulations, 2015, we forward below a Summary of Proceedings of the AGM of the Company held today i.e. Thursday, 26.08.2021 at 3:00 p.m.

Shri H R Kilachand, Chairman & Managing Director of the Company chaired the Meeting and called the meeting to order as the requisite quorum was present.

The Chairman informed that in view of the restrictions due to outbreak of COVID-19 and considering the social distancing norms, the AGM was conducted through Video Conferencing (VC)/ Other Audio-Visual Means (OAVM) in accordance with the Circulars issued by Ministry of Corporate Affairs and Securities and Exchange Board of India (SEBI). He also informed that e-voting platform during the AGM is now activated and members who have not cast their votes through remote evoting, may cast their votes during the AGM and until expiry of one hour after conclusion of proceedings of this meeting.

The Chairman further informed that all the Directors of the Company were present in the meeting through VC. He introduced the Directors present including the Chairpersons of Audit Committee, Nomination & Remuneration Committee and Stakeholders' Relationship Committee. The Chairman also informed the Members that representatives of Statutory auditors (M/s. V C Shah & Co., Chartered Accountants) and Secretarial Auditors (M/s. Ragini Chokshi & Co., Company Secretaries) were also present at the Meeting through VC.

The Chairman informed the members that the Company had provided the remote evoting facility to cast the votes electronically, on all resolutions set forth in the Notice and members who had not cast their votes yet and who were participating in this meeting would have an opportunity to cast their votes during the meeting through the e-voting system provided by Link intime India Private Limited.

As the Notice convening AGM was already circulated to all the members, the same was taken as read.

The Chairman informed that the Statutory Auditors' Report on Financial Statements did not carry any qualifications, adverse observations or comments on financial statements and other matters, which may have any adverse effect on the functioning of the Company. The said report was taken as read.

The Chairman further informed that Secretarial Audit Report had certain observations or comments and that the Board of Directors had responded to each of the observations in the Board Report adequately.

Then, the Chairman delivered his Speech, (a copy of which is being placed on the website of the Company).

Thereafter, the following resolutions/items as set forth in the Notice were taken up.

2	Appointment of Shri Harsh R Kilachand (DIN: 00294835) as Director, who retires by rotation at this 86th Annual General Meeting (AGM) and being eligible, offers himself for re-appointment (Ordinary Resolution)
	Special Business
3	Increase in Audit Fee of Statutory Auditors (Ordinary Resolution)
4	Ratification of Remuneration to Shri Rishi Mohan Bansal as Cost Auditor for Financial Year 2021-22 (Ordinary Resolution)
5	Re-Appointment of Shri Mahesh A Kuvadia (DIN: 07195042) as an Independent Director for 2 nd term of 5 years (Special Resolution)
6	Appointment of Dr. Narendra Mairpady (DIN: 00536905) as an Independent Director for 1st term of 5 years (Ordinary Resolution)
7	Appointment of Shri Rishabh Shah (DIN: 00694160) as an Independent Director for 1 st term of 5 years (Ordinary Resolution)

The Chairman read out the items except Item No. 2, which concerned the re-appointment of Shri H. R Kilachand, who retires by rotation. For Item No. 2, Shri H R Kilachand vacated the Chair and Shri M A Kuvadia, Independent Director took the Chair and read out the item. Shri H R Kilachand took the Chair again after that and read out the remaining items.

On the invitation of the Chairman, Members who had registered themselves as speakers, addressed the Meeting through VC/ OAVM and sought clarifications on the Company's accounts & businesses and items set out in the Notice. The Chairman responded to the queries of the Members and provided clarifications.

Thereafter, the Chairman informed the members that the e-voting on the Link Intime platform would continue to be available for the next 60 minutes and members who had not cast their vote yet can do so (e-voting facility was also made available to members throughout AGM). He further informed that the Board of Directors had appointed Mrs. Ragini Chokshi, Practicing Company Secretary, as the scrutinizer to supervise the e-voting process.

The Chairman informed that the voting results would be declared within statutory period. He authorized Mr. Gaurav Sharma, the Company Secretary, to declare the results of the voting, within statutory period and place the results on the website of the Company.

The meeting then concluded at 4:55 p.m. (including time allowed to shareholders to cast their votes electronically after proceedings of AGM were concluded).

Kindly note that relevant disclosures under Regulation 30 of the SEBI (Listing Obligations & Disclosure Requirements) Regulations, 2015 read with SEBI Circular No. CIR/CFD/CMD/4/2015 dated September 09, 2015, in respect of Item Nos. 5 (Re-Appointment of Shri Mahesh A Kuvadia as an Independent Director), 6 (Appointment of Dr. Narendra Mairpady as an Independent Director) & 7 (Appointment of Shri Rishabh Shah as an Independent Director) as considered in AGM were already filed with the Stock Exchange on November 13, 2020 (Item Nos. 6 & 7) and on June 30, 2021 (Item No. 5), when the respective directors were appointed as Additional Directors by the Board and hence, the same are not being filed again.
