**Father kills** 14-month-old baby RAICHUR: In a shocking case, a man killed his 14month-old baby in Karnataka's Raichur district as he felt that the child would hamper his chances of remarriage, officials said on Tuesday. The man confessed to the police that he committed the crime. The accused was identified as 32-year-old Mahantesh, a resident of Kanasavi village in Lingasugur taluk. The deceased child was known as Abhinava.

The petition, which was filed in the apex court on Tuesday by Lucknow-based advocate Ashok Pandey, said it is challenging the August 7 notification issued by the Lok Sabha restoring Gandhi's membership.
